JR Stillwell As Interviewed by Squadron 32 Commander Jim Peters

Can you tell us about your eligibility for the Sons and your families' military service?

Mike Lee Director Post 32 Riders My dad was in the Illinois National Guard and was already a Sergeant when they activated some of the Illinois National Guard for service on the Mexican border against Poncho Villa in 1913. He was equal to a Master Sergeant during WWI and served at Brest France. I don't know what his job was. He then went to Illinois National Guard Officer Candidate School and was commissioned in 1922. When the Japanese hit Pearl Harbor in 1941 he volunteered as an individual for active duty and was in by the middle of March. He spent most of his WWII time as an MP working in POW camps. He left active duty in 1946 and did not return to active Guard service. He later retired after credit for approximately 36 years.

You are a Veteran and a dual member. Can you give us some details of your military service?

I enlisted and took my basic training at Camp [now Fort] Chaffee, Arkansas and advanced training at Ft. Harrison. My schooling was how to job wire & operate all IBM machines (at that time - 1955). I spent 2 ½ years at Mason Forte (Orleans) France; but got transferred to an accounting section and became the supervisor for compiling the quarterly financial report for all Engineer supplies stored in our 3 Depots for the European Command. After I left active duty I stayed in the reserves for the next 23 years with all kinds of jobs. I spent my last 5 years in the reserve as the Chief Chemical-Biological-Radiological NCO for an area that covered most of the state of Indiana. After waiting for the proper age, I am now also a retired Master Sergeant.

When did you become involved in the Sons of the American Legion and what was your motivation?

I have always said that the Sons of the American Legion was [and is still, in some areas] the best kept secret in the American Legion. In my younger years I could not find a Squadron. After I enlisted, I was taking school in Ft. Harrison (Indiana) and found a downtown Post that put me in contact with a Squadron there. They sent me an application and I joined Robinson-Ragsdale Squadron 133 in Indiana by mail and belonged there for 5 years. I joined a Squadron in Dwight for a few years until we got Squadron 24 started. Then started working to get the 19th District and 4th Division and the Illinois Detachment started. Then with a few others from around the country, worked to get National organized.

You have been committed to your involvement in the Sons of the American Legion for many years. Why

did you put so much emphasis on the SAL as opposed to the American Legion?

My time on active duty was considered as the Korea era and I was eligible for the Korea GI Bill. However, at that time, my dates were not Legion eligible. So, to be as active as I could be with the American Legion my only membership was with the Sons of the American Legion. I became eligible for the American Legion when the Korea dates were changed in 1965.

We understand that you were directly involved with the writing of the SAL Constitution, bylaws etc. Can you please tell us about that?

The Reorganization Committee extended its charge, and the National organization allowed us to do a reorganization rather than a revamp. We worked on that for more than 2 years at special meetings that would be called to meet at National Headquarters in Indianapolis. I acted as the committee's unofficial secretary. There were some heavy discussions but, in the end, the 2 Sons of the American Legion members were able to say their piece and at times convince the other 2 or 3 that what we were asking for would work. And I guess we did a decent job as you can see where we are now.

What offices have you held with the Sons of the American Legion?

<u>District:</u> Adjutant; Finance Officer; Judge Advocate. <u>Division:</u> Adjutant; Finance Officer; Judge Advocate. <u>Detachment:</u> Commander; Senior Vice-Commander; Adjutant; Finance Officer; Judge Advocate; Assistant Adjutant; Recording Secretary (conventions 1 & 2) <u>National:</u> Chairman [Later changed to Commander]; Adjutant; Judge Advocate [served as 1 of 2 SAL voting members on the Legion - SAL Reorganization Committee 1971-76]

You are on record as serving as the National Commander of the Sons of the American Legion twice. Can you give us the story behind that?

The first 2 Chairmen (now Commander) served only for the Workshop they Chaired as those sessions were held at the National Convention of that year. They were credited for that membership year. I was elected in Portland in 1970 so I got credit for it. After we arrived in Portland the Legion SAL Committee announced that the individual that was elected for that Workshop would retain the Chairman title for the following year and Chair the Workshop for that year. So, 1 election, 2 membership year credits.

Senior Services of Central Illinois – Helping Seniors to Help Themselves

Senior Services of Central Illinois (SSCI) is a not-for-profit organization that has been offering a wide variety of non-medical services for individuals 50 years of age and older in Sangamon, Logan, Mason, and Menard counties since 1967. SSCI specializes in quality-of-life services, providing solutions to everyday problems so that seniors can continue to live independently, in their own homes, for as long as possible. The Care Coordination Unit (CCU) at SSCI provides a variety of services designed to assist individuals 60 and over to remain independent. CCU will determine needs, set up appropriate services, and follow-up to make sure services continue to meet needs. The Comprehensive Care Coordination Program, Choices for Care, Adult Protective Services, Information and Assistance, Senior Health Assistance Program, and the Volunteer Money Management Program make up the Care Coordination Unit.

The Comprehensive Care Coordination Program consists of certified Care Coordinators who provide in-home assessments to identify needs and strengths of each individual and develop client-directed care plans.

Choices for Care caseworkers complete a needs-based assessment in a hospital setting for patients who need further assistance after discharge to provide choices for long term care services.

Adult Protective Services responds to vulnerable persons who are alleged victims of abuse, neglect, and exploitation. Caseworkers develop and implement a care plan to stabilize the situation and reduce risk of further harm.

Our **Information and Assistance Program** directs individual and/or family members to available services and community resources which meet the individual's expressed needs.

The **Senior Health Assistance Program** (SHAP) Coordinator is responsible for outreach, information and assistance, and enrollment activities related to the Pharmaceutical Assistance Programs such as Medicare Part D.

The **Volunteer Money Management Program** assists limited-income seniors with managing finances.

Other casework led services provided at SSCI include the Caregiver Specialist Program and Elder Assistance Services.

The Caregiver Specialist program provides information and resources to caregivers of individuals 60 or over in Sangamon, Logan, Mason, and Menard counties.

Elder Assistance Services (EAS) provides one-on-one home or office visits for advocacy. EAS aids in dealing with physical,

family, or other related losses, as well as obtaining access to local, state, and federal programs such as Medicaid, Food Stamps, BEAM, and LIHEAP.

SSCI also offers two nutrition programs, transportation, programs and activities, travel opportunities, and the Illinois Senior Olympics.

Daily Bread is a midday meal program offered at 7 congregate sites in Menard and Sangamon counties. Daily Bread offers a nourishing meal, an opportunity for fellowship, informative programs and social activities. Home-delivered meals are available for individuals 60 or over who are home bound and on a general diet.

Springfield Specialty Meals on Wheels (SSMOW) is a homedelivered meal program focused on doctor prescribed, specialty dietary needs (low sodium, diabetic, etc.). The cost of a lunch meal is \$6.25. Participants may add a breakfast meal to their delivery for an additional cost of \$2.25. Currently, delivery is available in Springfield only.

Senior Transport provides transportation to participants, 60 or over, as well as individuals with disabilities, living in Sangamon County. Vehicles are wheelchair accessible. Reservations are required. There is a suggested donation of \$2.50 per oneway ride for individuals 60 or over, and a required fee of \$2.50 for individuals under the age of 60.

Programs and Activities at "The Center" such as fellowship, dance classes, exercise classes, art classes, entertainment, crafts, health programs, volunteer opportunities, and more are held daily. The Gift Shop offers a variety of items handcrafted by seniors who come to The Center.

Trips & Travel Opportunities offer individuals exciting and adventurous day trips as well as extended trips. Day trips are offered to nearby destinations such as St. Louis, Southern Illinois, Peoria, Chicago, and more. Extended trips are planned for all over the U.S. and World. Some examples are Missouri, South Dakota, Pennsylvania, Canada, Iceland, and Germany. Individual costs vary for each travel opportunity.

The Illinois Senior Olympics promotes healthy lifestyles for individuals 50 or over. The games, which include more than 20 events and 3 team sports are an excellent way for older individuals to be fit, active, and improve their physical and mental health. A great opportunity to socialize, enjoy some friendly competition, and engage the entire family. Springfield is the only qualifying site in Illinois for athletes that would like to participate in the National Senior Games. Visit the ISO website at www.llseniorolympics.org.

Greetings Fellow American Warriors. Last August, I became the owner of Can Am Spyder with no direct riding experience. I learned of a national riding program called Tour of Honor (See picture to the right). The Tour is an organization run by veterans to fund veteran organizations. April 1 – October 31, registered riders visit memorial sites listed for each state and are scored accordingly. Unique to the 2023 Tour is its focus on celebrating Vietnam Veterans and memorial sites dedicated to those veterans. 2,500 riders are permitted for the Tour each year.

The TOUR program has been around seventeen years so to get a flag number two things need to happen; a previous rider must decline participation by choice or by dying. I was fortunate to get registered with Flag #200 **(See My Flag to the right)**. My goal was to complete all the scored sites for three states. I completed Iowa in three days and what a trip it was. Why participate in the program? For me it is heal the open wounds from the past. I am riding for three Vietnam Veterans who impacted my life, two are deceased and one is living.

This experience has been very cathartic. I was raised in a military family, on military bases and returning to central Illinois during the Vietnam era sheltered me from the ugliness my fellow Americans demonstrated toward the valiant warriors who fought in their honor. Vietnam Veterans did not speak of this repudiation, at least the ones I served with. I have come to realize the impact it has taken on loved ones who served during that very tumultuous time. For this reason, I ride.

On a lighter note, Post 32 had a contested Jr. Vice election, and the winner is David Cooper, a Navy veteran. Legionnaire Cooper has been member of the Post and wishes to be more involved.

Meet Bill Mowder, Post Service Officer at Post 32

My name is Bill Mowder, and I am your new Post Service Officer. I retired from the USAF after serving 23 years. The agency specialized in working with HUD, first time buyers and Section 8 housing programs for veterans.

I have just been appointed to the Veterans Assistance Commission of Sangamon County. The purpose of this Commission is to promote the welfare of veterans of the uniformed services of the United States of America whose final discharge is either Honorable or General Under Honorable Conditions.

variety of Evidence Based Programing, such as the Aging Mastery Program, Bingocize, A Matter of Balance, and Savvy Caregiver.

The Aging Mastery Program is a fun, innovative program that empowers seniors to take key steps to improve their wellbeing, add stability to their life, and strengthen ties to their community. This is a ten-course program that covers topics such as Exercise, Healthy Eating, Financial Fitness, Medication Management, and more.

Bingocize combines exercise and health information with the familiar game of BINGO. This has shown itself to be a great, fun way to get seniors moving and socializing. Bingocize is held at 10:30 am every Friday at the Springfield Senior Center.

A Matter of Balance is a structured program consisting of 8 sessions that include group discussion and light exercise. This program is designed to benefit older adults, whether you have a history of falls, or are just wish to become more active.

Savvy Caregiver is an eight-week course designed to assist caregivers of dementia patients in meeting their needs by provides caregivers with new coping skills.

Proper Disposal of Old Glory – American Flags Mike Walton, Post 32 Finance Officer

When an American Flag becomes unserviceable, they are to be disposed of with honors. Springfield Post 32, The American Legion, conducts a minimum of two "Dignified Disposals of Unserviceable Flags" ceremonies per year. One ceremony near Flag Day (June 14) and one near Veteran's Day (November 11). This ceremony, involving the Post Commander, Senior Vice Commander, Junior Vice Commander, Sergeant at Arms and Chaplain is conducted to honor the Flags being disposed of. The retired Flags are then destroyed, one by one, by Fire. Always remember:

"A flag may be a flimsy bit of printed gauze or a beautiful banner of finest silk. Its intrinsic value may be trifling or great; but its real value is beyond price, for it is a precious symbol of all that we have worked for and lived for and died for - a free nation of free men and women, true to the faith of the past, devoted to the ideals and practice of justice, freedom and democracy."

Springfield Post #32, The American Legion, maintains an unserviceable flag drop box at the entrance to our Post at 1120 Sangamon Avenue. People may also drop them off at Butler Funeral Home, Ace Hardware, and Noonan's locations in Springfield, as they are kind enough to assist us with the collection of the flags. An American Flag is never to be disposed of in any other way than by a dignified flag disposal ceremony.

3. Drawing will be the 4th Monday of every month at 6:50 p.m. at American Legion Post 32, 1120 Sangamon Avenue, Springfield, Illinois under the direction of the American Legion Post 32 Raffle steering committee. Any disputes regarding the administration of this raffle, the Raffle steering committee shall have final authority. The amount of the prize will be determined by the number of tickets sold. The winner will receive one-half of the money collected from the ticket sales.

4. Tickets are \$1 each or 6 for \$5. These tickets will be double roll style. You must purchase a minimum of one ticket and print legibly your name and phone number on the tickets purchased.

5. The winner does not need to be present to win. If the winner is not present at the time of the drawing, the person conducting the drawing will contact them by phone and the winner

will have seven days to claim their winnings. Winnings can be claimed at the Bar with proper Identification. Any unclaimed winnings will become the property of Post 32.
